

Tall Grass and Fire Prevention

As we turn to warmer weather and dream of the summer sun, the City of Veneta is working hard to ensure that fire risk is as low as possible. While the City is working to lower local fuel loads and building partnerships with agencies like the Lane Fire Authority, you can also work to protect yourself and your neighbors from fires.

Keeping tall grass, brush, and other noxious vegetation controlled is the main step residents can take to ensure they are keeping themselves,

their homes, and their community resistant to fires. The City of Veneta Municipal Code (8.05.060) requires residents to prevent such vegetation from growing and enforcement takes place June 1-September 30. Take advantage of the current low fire risk to use your tools and get the garden in order!

Of course, if a fire event does happen, you should be aware that local authorities use a

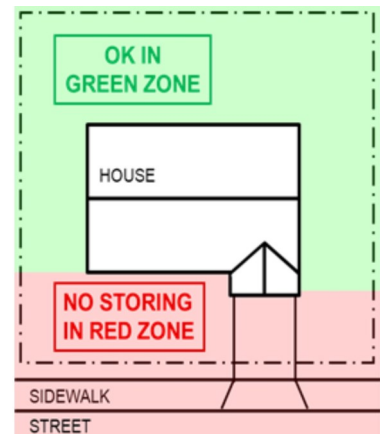

Recreational Vehicle Parking

The City of Veneta is dedicated to ensuring our neighborhoods feel safe, comfortable, and pleasant to live in. A growing obstacle to that goal is the increasing prevalence of recreational vehicles (RVs) being parked improperly and/or in the right of way. This has been a growing problem: vehicle-related complaints were at 31 in 2019, 29 in 2020, and hit 40 in 2021. With 20 complaints already in 2022, we are on track to see the trend continue to grow. The City of Veneta would like to remind its residents of the proper means to store RVs, travel trailers, and boats.

The Veneta Land Development Ordinance allows for the storage of RVs and the like as long as they are not being used for human habitation and they are **not stored in the front of a resident's property**. The graphic next to this

“Ready, Set, Go” system for managing evacuations. For you and your family’s safety, it is important to know what these levels mean if you get the alert:

Ready: There is a risk in your area. Have bags packed and supplies ready in case of an evacuation.

Set: There is a significant risk in your area. Be ready to leave at a moment’s notice, if you have not left already.

Go: There is an immediate danger to you and you must evacuate.

While the City hopes that the steps we and the

community take will prevent such an event, knowing these steps will be important for you and your family to know.

article shows the general areas around a home that RV parking is and is not allowed. Further, the Veneta Municipal Code, 10.05.130, explicitly prohibits RVs, travel trailers, and boats to be parked on public property, street, or right of way longer than 48 hours. Those 48 hours do not reset if the vehicle is moved – without proper storage, RV owners can expect fines to accrue on their improperly stored vehicle.
