## Hazardous Vegetation

Have you noticed that Fire Season seems to start earlier and earlier each year?

The City of Veneta is looking at new rules regarding high grass and weeds that can lead to an increase in fire danger. Currently, high grass and weeds season begins in June. The new rules would require weeds and tall grass over 10 inches to be mowed down for fire safety between May 1<sup>st</sup> and September 30<sup>th</sup>.

On February 12<sup>th</sup>, the City Council will hold a public meeting on amendments to Veneta Municipal Code, Section

8.05.060, Noxious and Hazardous Vegetation, in order to determine if mowing should happen one month earlier.

The proposed amendments also include adding invasive weeds to the list of noxious vegetation, as well as adding a requirement for a 30-foot fire buffer around large parcels greater than 1 acre in size.

## Rate Increase Reminder

The new water and sewer rates went into effect on January 1, 2024. The residential Water Base rate increased 3% changing the rate from \$17.82 to \$18.46. The residential Sewer Base rate increased 2% changing the rate from \$64.93 to \$66.23.

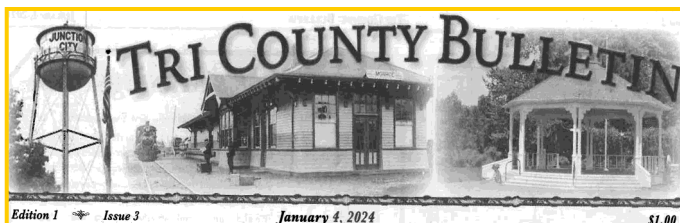

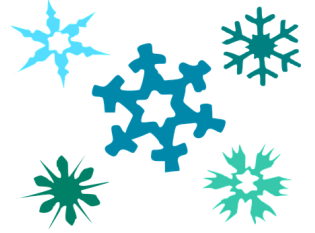
## Department Updates

### ADMINISTRATION

- WHEW! That January ice storm snuck up on us, but the City infrastructure came out largely unscathed. The power outages caused some havoc with our water and wastewater treatment plant computers, but Lane Electric and EPUD got us back online relatively quickly when you consider that there were people without power in Lane County for a week or more. A "Tip of the Hat" to both Public Works Superintendent Kip and Utility Worker Justin for keeping our water treatment plant and wastewater treatment plant running through the multi-day ice storm. They were up early and late taking the initiative to address issues that arose from the freezing temperatures. All in all, the City escaped significant damage. The fence at the wastewater treatment plant took a hit and the power outage at the pool damaged a sump pump. There were some clean up and repairs, in addition to lots of downed limbs moved out of the roadway. The City also helped clear the Veneta Elementary parking lot so that people still without power could go charge devices and warm up.

- The Oregon Department of Land Conservation and Development has closed the National Flood Insurance Program Community Assistance Visit for Veneta. They started this "Visit" a few years ago and finally gave us the thumbs up! Among the hoops we had to jump through included: Updating our floodplain regulations utilizing the Oregon Model Flood Hazard Ordinance; updating our floodplain development permit utilizing the Oregon Model Floodplain permit; providing Standard Operating Procedures for floodplain management; and providing them as-built documentation from Public Works to demonstrate development compliance with "Before Floodway" provisions in the city's floodplain code. WHEW!! At least they told us: "We appreciate the work you have put into improving the city's floodplain program."



## ECONOMIC DEVELOPMENT

- Two years after issuing a request for proposals to develop the City's property at 24993 W. Broadway, commonly known as "The Attic," the sale of that property is happening! The owners of the West Lane Gym will acquire The Attic property and create a community gathering and indoor/outdoor eatery featuring food truck cuisine. The City is excited to see the Downtown Veneta business district grow as a place for our community to enjoy our small town.
- The City of Veneta supports the Veneta Fern Ridge Chamber of Commerce with Rural Tourism and Marketing Program funds received from Lane County that must be spent on tourism-related materials and services. This supports staffing the Visitors Center at the Chamber, in addition to other economic development programming support.

We struggled for a while to find the right fit, but boy did we add to an already great staff. The city has hired new staff members who are top notch professionals. 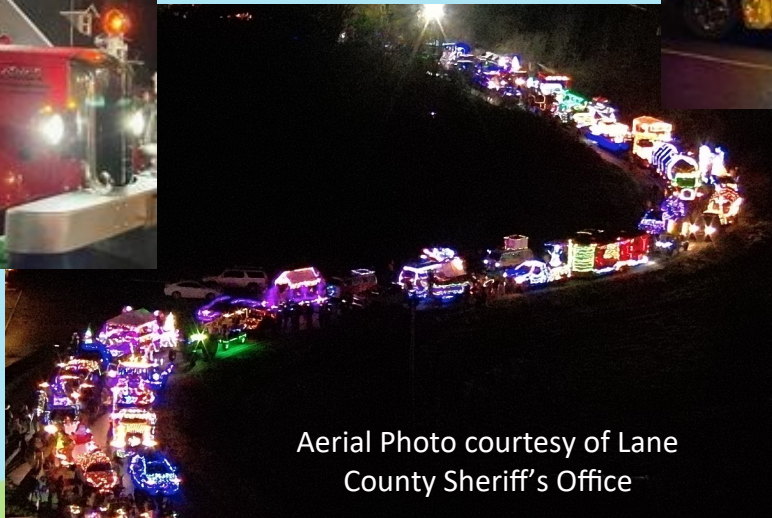

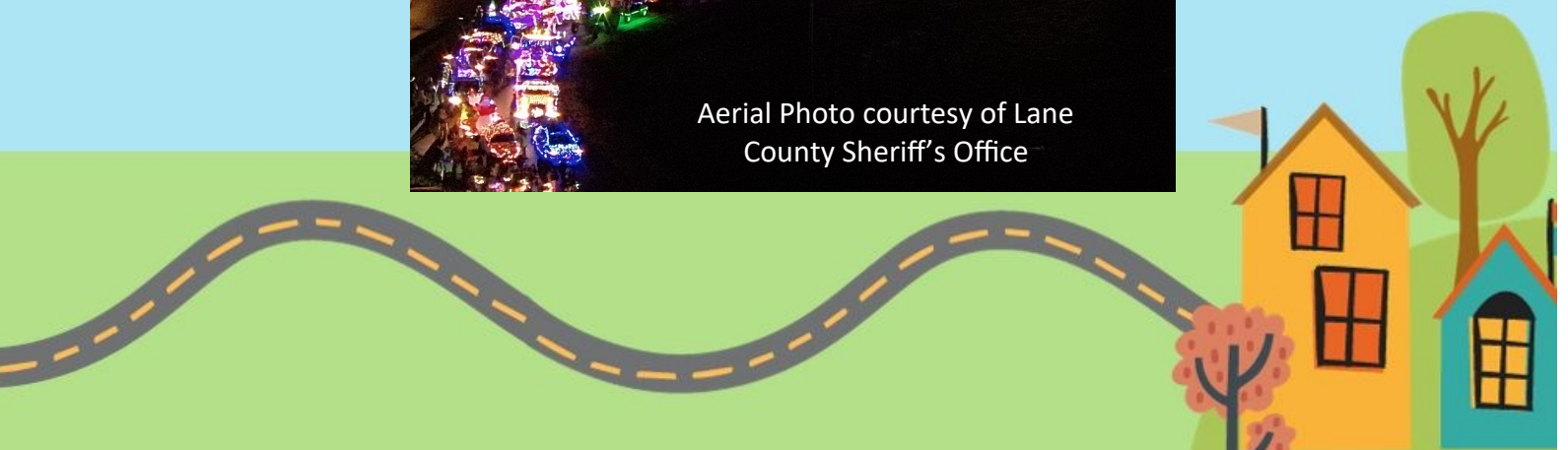

## Administrative

We were very disappointed to find out recently, that the grant for funding of the Huston to Lakeside Drive portion of the 126 extension project we were hoping to receive has been put off for another year. We are still in hopes of improving the Huston Road intersection.

I have been promising for some time now improved high speed internet for the whole city and it looks like this year should be the culmination of that. We have already installed it in the Fern Ridge Service Center and the Public Works yard. Look for more information on that soon.

We are continuing to improve how we communicate with our residents. We have an improved Monthly Newsletter and you can now sign up on our new website to receive email notices when a new agenda comes out or a page is updated.

## Public Works

The Public Works Department under the keen eyes of our Director, Kyle Schauer, and Superintendent, Kip Orme, keeps our city beautiful and safe on a daily basis. They do set up and tear down for most of our events and are really the face of our staff. No matter how much work they seem to have, they always have a smile and wave for those who pass by.

## Community Development

The city continues to partner with the Corp of Engineers, Lane County and the State of Oregon to provide a new path between Elmira and Veneta to make it safer for all, including our students, to walk or bike between the towns. The city has matching funds available to add to the potential grant.
