Pickleball for the People

In 2020, the City of Veneta engaged with the community to update the twenty-year old Parks, Recreation, and Open Spaces Master Plan. As a result of public surveys, open houses, and public outreach at open air events, the community's voice most commonly spoke about three desirable park elements: biking/walking trails, an off-leash dog park, and pickleball/tennis courts. Since the



adoption of the new Parks Master Plan, the City has been pursuing each of these three elements. The City Council adopted the Paths & Trails Master Plan, and this summer construction will begin on an off-leash dog park at Territorial and Brooker Lane, and four pickleball courts at Territorial Park.

Focusing on the pickleball courts at Territorial

City Council Approves Matching Grant for Expansion Project

Upon thorough review and deliberation, the Business Assistance Committee presented its recommendation to the City Council on February 12th to award a \$25,000 matching grant to Hillbilly Brews for expansion of their Jeans Road and Territorial Highway location.

The City Council earmarked funds in the city budget to aid enterprises like Hillbilly Brews in expanding local operations. The process behind

the allocation of such grants is in-depth and transparent. Applications undergo rigorous scrutiny by the Mayor-appointed 5-person Business Assistance Committee. This committee diligently evaluates each application, considering factors such as the proposed expansion plans, potential impact on the local economy, and the business's track record within the community. Understanding the Vital Role of Stormwater Management

Stormwater, often overlooked, plays a pivotal role in the health of our environment and communities. It encompasses the runoff from rain and snowmelt that flows across surfaces, collecting pollutants and debris along the way. Despite its seemingly mundane nature, stormwater management holds immense importance for several reasons.

First and foremost, effective stormwater management helps prevent flooding properties. When rainwater cannot infiltrate the ground due to impermeable surfaces like pavement and concrete, it accumulates rapidly, leading to flash floods that can wreak havoc on infrastructure and endanger property and lives. Proper drainage systems, including retention ponds and green infrastructure, mitigate this risk by efficiently channeling excess water away from populated areas.

Moreover, stormwater management contributes significantly to water quality preservation.

Department Updates

ADMINISTRATION

- City Hall hosted thirteen Elmira High School Seniors for a half-day Job Shadow visit. They met Mayor Keith Weiss, Councilors Pat Coy and Alexa Benson as well as staff members. Together, the kids and City conducted a mock city council meeting. It was a fun time and a really good opportunity for local kids to experience how a city council makes decisions for the community.
- You can catch the January and February 2024 editions of the Veneta City Council Highlights video on the City's website under Agendas & Minutes when you click on the City Council arrow to open the 2024 agendas. Look for the little TV icon for those summary videos.
- Starting March 1st Sanipac curbside waste service rates will increase 4.21% for all debris container sizes and frequency of pick-up (weekly or every-other-week).
- The City is pursuing two federal FEMA grants for an architectural seismic review of the planned replacement Community Center at City Park and a City Hall expansion. In the event of a Cascadia earthquake event, the City will need operations and public spaces in the aftermath. Fingers-crossed for the grants!
- The City's auditors submitted the fiscal year (July 1 to June 30) 2021-2022 audit to the Oregon Secretary of State. The City also filed the audit with the municipal bond market clearinghouse, EMMA, as part of our reporting responsibilities for the City's wastewater bond debt. We'll get to work on the fiscal year 2022-2023 audit and, at the same time, start developing the fiscal year 2024-2025 preliminary budget for the City's Budget Committee to review in May.
- If you are hearing-impaired you can use the 7-1-1 Oregon Relay service to contact City Hall to pay your city utility bill or handle any other transactions. 7-1-1 Relay is a free service that hearing-impaired people can utilize to call others.

COMMUNITY DEVELOPMENT

- The City plans to sell a surplus 0.20-acre residential zoned property on the SW corner of 7th and Hunter Street. The City held a closed bid process throughout February with a minimum acceptable bid of \$50,000. Bids were opened on February 23rd and staff will recommend a sale to the selected bidder at the City Council's March 11th Council meeting.
- The City has been working with the State of Oregon on a grant to build a sidewalk cover for the Fern Ridge Service Center Love Project food bank. The project has been accepted for funding so City Staff have been working on getting all the paperwork signed in the right spots!

PUBLIC WORKS

- There's some new trees planted at City Hall! Public Works team members Mark and Mike planted three in the front and one in the back after removing two over-bushed bushes. The new trees will have some beautiful color in fall and stay low enough to keep away from overhead power lines.



PUBLIC SAFETY

- We said a few fond farewells to Veneta-based Lane County Sheriff's Office (LCSO) Deputy Meyers as he moves from the Veneta Contract to LCSO's ocean beach patrol. We'll still see Deputy Meyers on occasion at Veneta's National Night Out in August and December's Light Parade.

Park, the plan is to build them between the skate park and playground. This park was chosen because it offered the only site large enough for the courts while providing some distance from residences. The City is working with project designers to evaluate several noise mitigating strategies in addition to distance. For example, the elevated skate bowl will mitigate noise to the east, while the fencing surrounding the pickleball courts will be strong enough to bear sound-dampening ma-

terial where needed. No lights will be installed so play will only be allowed during daylight hours. Construction is expected to begin this summer and completed by fall.

Adding pickleball courts as a popular adult activity will bring a new mix of park users to Territorial Park. Not that adults don't use the skate bowl or the basketball courts—they do! A new park amenity like this will enhance Veneta, making it an even nicer place to enjoy with your family and friends.



As runoff travels over roads, lawns, and construction sites, it picks up various pollutants such as oil, sediment, and chemicals, ultimately depositing them into water bodies. These contaminants degrade aquatic habitats, harm wildlife, and compromise the safety of drinking water sources. By implementing filtration systems and erosion control measures, communities can reduce the influx of harmful substances into rivers, lakes, and oceans, safeguarding both ecosystems and public health.

Furthermore, stormwater management plays a crucial role in replenishing groundwater reserves. In natural environments, precipitation seeps into the soil, replenishing underground aquifers that serve as vital sources of drinking water. However, urbanization disrupts this process by replacing permeable landscapes with impervious surfaces, limiting the recharge of groundwater supplies. The City used permeable asphalt at the Park & Ride parking lot adjacent to the Our Daily Bread restaurant parking lot. Through sustainable practices such as rainwater harvesting and permeable pavement, cities can restore balance to the hydrological cycle, ensuring the availability of clean, freshwater resources for future generations.

In conclusion, the significance of stormwater management cannot be overstated. From flood prevention to water quality enhancement and climate resilience, its multifaceted benefits extend far beyond mere drainage. Prioritizing sustainable stormwater practices is essential to fostering healthy, resilient communities and safeguarding the integrity of our natural environment for generations to come.
