RESOLUTION NO. 1047

A RESOLUTION ESTABLISHING DOG LICENSING AND OTHER ANIMAL CONTROL FEES AND FINES FOR THE CITY OF VENETA; AND REPEALING RESOLUTION NO. 1046

WHEREAS, Veneta Municipal Code Chapter 6.05.090 requires that the Veneta City Council adopt a resolution setting forth all licensing and other animal control fees; and,

WHEREAS, Veneta Municipal Code Chapter 6.05.100, 6.05.110, 6.05.130, and 6.05.160 establish guidelines for certain fees; and,

WHEREAS, Veneta Municipal Code Chapter 6.05.260 allows the City to set fines; and,

WHEREAS, Chapter 659 Oregon Laws 2009 (HB 2287) directs courts, including municipal courts, to add a \$45.00 surcharge onto the base fines (bail) and minimum fines on all violations, except parking, for citations written on or after October 1, 2009 and before July 1, 2011; and,

WHEREAS, the State Legislature has directed that the surcharge may not be waived if a fine is imposed; and,

WHEREAS, the Veneta City Council amended its Animal Control Ordinance to include several new violations;

NOW, THEREFORE, BE IT RESOLVED by the City Council for the City of Veneta, as follows:

Section 1. The following dog fees are hereby established:

Three (3) Year	\$ 70.00
Neutered Dog License: One (1) year	\$ 15.00
Two (2) Year	\$ 25.00
Three (3) Year	\$ 35.00
Senior Citizen (65 years of age or older)	½ fee
Guide or Aide Dog	Exempt
Commercial Kennel License (requires land use approval prior to issuance of license)	\$150.00
Watch Dog Permit (plus annual license fee)	\$ 25.00
Replacement Tag (duplicate license)	\$ 5.00
Late Fee (renewed 30 days after license expires)	\$ 10.00
Impound Fee	\$ 50.00
Daily Care Fee for Animal held by City (maximum per day)	\$ 30.00
Daily Care Fee for Animal held by Contract Agency	Set by Agency
Medical Care Fee – the owner of an animal requiring medical care from a veterinarian shall be responsible for all costs of treatment, together with the cost of moving, destroying, or disposing of the animal. Medical care fees shall be determined by the Veterinarian who treats an animal impounded by the City.	

Section 2. Surcharge.

a. Pursuant to Chapter 659 Oregon Laws 2009 (HB 2287) a surcharge shall be imposed in the amount of \$45.00 on all convictions for violations on citations written on or after October 1, 2009 and before July 1, 2011.

b. The surcharge shall be added to the base fines (bail) listed in Section 3 below.

c. The surcharge may not be waived.


Section 3. The following animal control base fines and bail schedule are hereby established:
